Minimum Qualifications:

- i. LLM (IP) or (IPR) or equivalent with minimum 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) and
- ii. Ph.D in Law preferably in the field of IPR.
- iii. A minimum of eight years of experience of teaching and/or research in an academic/research position in the field of IPR equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals out of which five publications must be in the area of IPR and a total research score of seventy five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulations 2018.

GENERAL INSTRUCTIONS

- a. Please read **General Guidelines** from the website of University https://recruit.cusat.ac.in.
- b. A working e-mail id of the candidate shall be given in the application: All communications in connection with the recruitment will be sent to the registered e-mail id only and hence the candidates are directed to check their e-mail periodically.
- C. Age: Age as on 01.01.2023 Maximum age for considering against State Government / State Government (Quasi) vacancies is limited to 50 years.
- d. Other conditions:

- 1. The appointment against the above vacancies will be made as per UGC Regulations and Reservation Principles according to Cochin University of Science and Technology Act, 1986 and Kerala State Government Rules.
- 2. A relaxation of 5% shall be allowed at the Bachelor's as well as the Master's Level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-Creamy Layer) / Differently-abled for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading System is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on qualifying marks without including any grace mark procedure.
- e. Any corrigendum/addendum shall be posted only on the University website.
- f. The applicants should possess the minimum qualifications as on the last date for submission of application (online), failing which the application will summarily be rejected.
- g. Shortlisting of candidates will be based on the credentials as on the last date of application (online submission). Qualifications, publications, conference etc. after the last date will not be considered in any case.

h. How to apply:

- 1. Applications to the above posts have to be submitted online in the prescribed application form available in the University Website: https://recruit.cusat.ac.in
- 2. Degrees obtained from National Institutes like Indian Institutes of Technology (IITs), Indian Institute of Science (IISc), National Institutes of Technology (NITs), Indian Institute of Science Education and Research (IISERs) or other institutions recognized by University Grants Commission (UGC) and degrees obtained through regular mode from Universities / Institutions listed under UGC Act, Section 12(B) are exempted from the requirement of Recognition Certificate. However, candidates who have obtained degrees from other Institutions/ Universities shall forward the Recognition Certificate obtained from this University along with their application.

Candidates who have passed the qualifying examination/Ph.D. from Universities abroad should submit Equivalence Certificate issued by the Association of Indian Universities, AIYU House, 16 Comrade Indrajit Gupta Marg, New Delhi – 2 (Equivalence Division).

- 3. Candidates should apply online on or before **30.11.2023**.
- 4. One signed hard copy of the filled up online applications (Part A & Part B) along with copies of documents to prove age, community, qualifications, percentage of marks, experience, copies / reprints of publication (if any) with proof of impact factor etc.
