GENERAL INSTRUCTIONS

- Reservation will be available to differently-abled persons as provided in the Rights of Persons with Disabilities Act, 2016 / Court Judgements and any other relevant Government Orders and Circulars issued from time to time.

All communications in connection with the recruitment will be sent to the registered e-mail id only and hence the candidates are directed to check their e-mail periodically.

d. Qualifications and Experience:

Instruction Sheet No. II of the Notification containing details of qualifications prescribed for the posts can be downloaded from the website of University, <https://recruit.cusat.ac.in/>

- Age:** Age as on **01.01.2024** – Maximum age for considering against State Government / State Government (Quasi) vacancies is limited to 50 years.

f. Other conditions:

1. The appointment against the above vacancy will be made as per UGC Regulations and Reservation Principles according to Cochin University of Science and Technology Act, 1986 and Kerala State Government Rules. The posts earmarked for Reserved Categories are exclusively reserved for them as per the provisions in the Kerala State & Subordinate Service Rules.
2. **The natives of States other than Kerala shall not apply for the posts notified exclusively under community reservation quota (SC/ST/Other Backward Communities/EWS/Differently abled) as per the provisions in the Kerala State & Subordinate Service Rules, 1958, as amended from time to time.**
3. *Only persons having minimum 40% disability shall be eligible for reservation / concessions set apart for the Persons with Disability (PwD). The Person availing the reservation for Persons with Disabilities shall invariably submit a Disability Certificate issued by a Medical Board duly constituted by the State / Central Government.*
4. *A relaxation of 5% shall be allowed at the Bachelor's as well as the Master's Level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-Creamy Layer) / Differently-abled for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading System is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on qualifying marks without including any grace mark procedure. A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.*

g. Any corrigendum/addendum shall be posted only on the University website.

h. The applicants should possess the minimum qualifications as on the last date for submission of application (online), failing which the application will summarily be rejected.

i. Shortlisting of candidates will be based on the credentials as on the last date of application (online submission). Qualifications, experience, publications, etc. after the last date will not be considered in any case.

j. How to apply:

- Application to the above post has to be submitted online in the prescribed application form available in the University Website: <https://recruit.cusat.ac.in/>
- Degrees obtained from National Institutes like Indian Institutes of Technology (IITs), Indian Institute of Science (IISc), National Institutes of Technology (NITs), Indian Institute of Science Education and Research (IISERs) or other institutions recognized by University Grants Commission (UGC) and degrees obtained through regular mode from Universities / Institutions listed under UGC Act, Section 12(B) are exempted from

the requirement of Recognition Certificate. **However, candidates who have obtained degrees from other Institutions/ Universities shall forward the Recognition Certificate obtained from this University along with their application.**

- Candidates who have passed the qualifying examination/Ph.D. from Universities abroad should submit Equivalence Certificate issued by the Association of Indian Universities, AIYU House, 16 Comrade Indrajit Gupta Marg, New Delhi – 2 (Equivalence Division).
- Candidates who are employed on regular basis in Government/Quasi Government/State Autonomous Organization should forward their applications through proper channel with No Objection Certificate. However they can send an advance copy to the Registrar directly.
- Candidates must sign in the the space provided in the application form. **Unsigned application will be rejected.**
- Candidates must affix a photograph (the same used for uploading the online application) on the right top portion of the application which shall be duly attested by a Gazetted officer.
- Conduct certificate obtained (not earlier than 6 months from the date of notification of the post applied) from either the Mayor of Corporation/ Chairman of Municipality/ President of Panchayat/ Member of Legislative Assembly/ Member of Parliament or Gazetted officers of the Central Government/State Government/University shall be attached in original with the application.
- Candidates should apply online on or before **10.10.2024**.
- **All the papers corresponding to a particular serial number of the post shall be bound together** (preferably spiral bound) with a facing sheet bearing the caption. Application for the post of (SI No..... Name of post with Reg No. in respect of Mr./Ms/ Dr.
- One signed hard copy of each filled up online applications (Part A & Part B) along with copies of documents to prove age, community, qualifications, percentage of marks, experience, copies / reprints of publication (if any) with proof of impact factor etc. should reach the Registrar, Cochin University of Science and Technology, Kochi – 682 022 **before 5.00 PM on 17.10.2024**. Candidates who have applied online but failed to submit the hard copies of the application in time will not be considered for selection.

Minimum Qualifications: A or B

A.

- i. M.Sc with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in **Forensic Science. Candidate must have studied 'Forensic Biology' as a part of the Master's Degree**, from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET. The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.

Candidates who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations 2009 or 2016 and their amendments from time to time as the case shall be exempted from NET/SLET/SET:

Provided, the candidates registered for Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye- laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor, subject to the fulfillment of the following conditions:-

- a. The Ph.D. degree of the candidate has been awarded in a regular mode;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e. The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Desirable: Ph.D. Degree in relevant/allied discipline.

OR

B. The Ph.D. degree has been obtained from a foreign University/Institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).
